My granddaughter had an incident at school...

Her father works out of town, so many things wait until he is home to discuss. He came home unexpectedly early one day, and she was thrilled until she remembered she had to tell him what had occurred. She stopped her mom before they went into the gate and asked if he "knew" yet. Mom said no that they would talk to him. Granddaughter said she would just go upstairs to her room and let Mom tell him. She walked right past Dad without talking and went straight up to her room. She hesitantly returned about 15 minutes later. Dad was sitting on the couch watching cartoons and told her to come sit with him. She inched closer and hesitantly took her normal place under his arm. She sat uncertain and slightly distant. Puzzled, she got Mom's attention and whispered "Did you tell him?" and Mom nodded yes. She looked at her Dad, and he folded her closer to him as they watched cartoons. She looked up at him and relaxed into her place understanding her father's love was bigger than any problem she faced.

This reminded me of our Father. We can separate ourselves from his love and protection rather than seeking him and letting him comfort us.

Call to Order: Cindy Krause called the meeting to order at 7:00 pm and opened with prayer.
